THE NAPA COUNTY JAIL OFFERS SENTENCED INMATES SEVERAL OPTIONS TO MAKE THEIR INCARCERATION PRODUCTIVE. PLEASE FOLLOW THROUGH WITH AN ASSESSMENT OF THOSE OPTIONS.

PROCESS

AFTER LEAVING THE COURT HOUSE- FOLLOW THE CORRIDOR BETWEEN THE COURT HOUSE AND THE COUNTY ADMINISTRATION BUILDING SOUTH TOWARDS THE HALL OF JUSTICE. ONCE INSIDE THE HALL OF JUSTICE YOU CAN RECEIVE AN APPLICATION AT THE FRONT COUNTER.

AFTER RECEIVING YOUR APPLICATION AT THE FRONT COUNTER OR ON-LINE (SEE BELOW), YOU MAY RETURN YOUR APPLICATION TO CLERICAL STAFF AT THE FRONT COUNTER OF THE NAPA COUNTY DEPARTMENT OF CORRECTIONS, IN THE LOBBY OF THE HALL OF JUSTICE.

CLASSIFICATION STAFF WILL REVIEW THE APPLICATION AND CONSIDER YOUR OPTIONS. THE APPLICATION IS SPECIFIC AND YOU MUST FOLLOW THE DIRECTIONS.

UNLESS DIRECTED OTHERWISE YOU **MUST** REMAND AS DIRECTED.

IF YOU ARE FACING A JAIL SENTENCE, YOU HAVE AN OPTION TO TRY AND MAKE IT AS PRODUCTIVE AS POSSIBLE.

NCDC OFFERS SOME OPTIONS

- Inmate Worker- Work in the facility's laundry, kitchen, cleaning crew, public works.
- Chipper Crew- Working with Cal-Fire you could clear brush and help protect the community from the risk of wild land fires.
- Work Furlough- If you have a job you may qualify for Work Furlough- SUPPORT YOUR FAMILY WHILE SERVING YOUR SENTENCE. (1 HOUR'S WAGES PER DAY)
- Short term inmates may be eligible to perform community service via our CCC program. (\$50 A DAY)
- Electronic Monitoring- is available, on a very limited basis.

THE APPLICATION IS SELF EXPLANATORY AND YOU ARE EXPECTED TO PROCESS IT AND FOLLOW THE DIRECTIONS. HOWEVER, IF YOU HAVE QUESTIONS PLEASE CONTACT CLASSIFICATION STAFF AT:
