4. Do not leave California without permission from the probation officer. You waive extradition to this state. Seek and maintain full-time employment, school, or vocational training. Provide prints and biological samples (PC296).
5. Pay a \$ 1000. fine. This includes all penalty assessments and security fees.
6. Serve _____ hours days on the Court Work Program in a manner to be determined by Post Court Services.
7. Serve 4 hours days in jail. Go to Napa Co. Jail at 8:00 a.m. on 11/15/08 and follow their orders about serving your time.

9. Pay the jail booking fee set by Napa County.

11. Pay a \$ 100. restitution fine and an identical probation revocation restitution fine which is suspended unless probation is revoked.

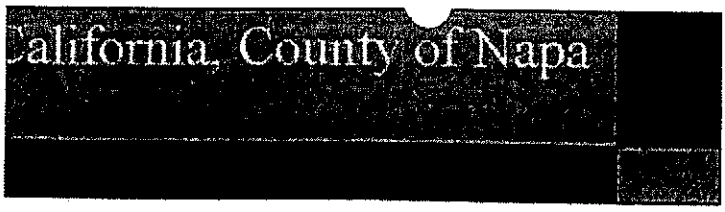

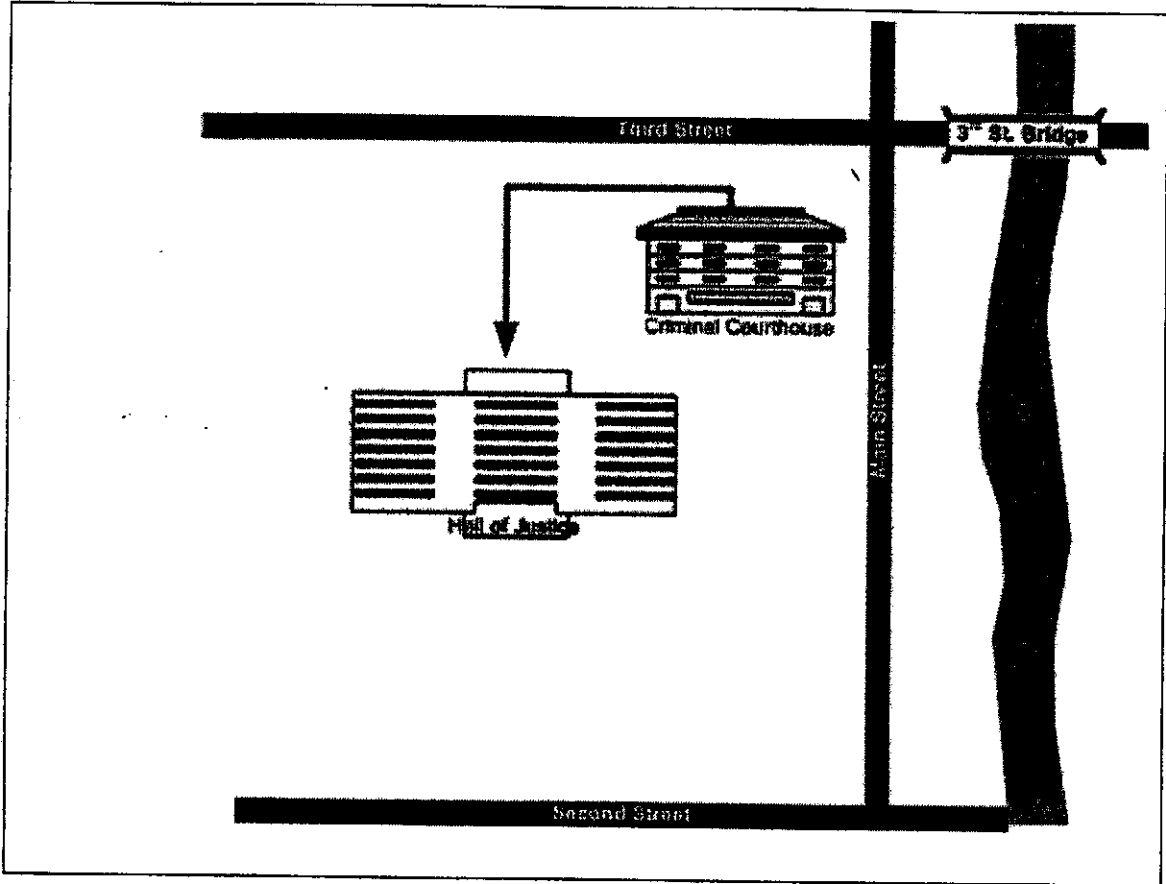
